Introduction:

What a publication scheme is and why it has been developed?

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- The classes of information which we publish or intend to publish;
- The manner in which the information will be published; and
- Whether the information is available free of charge or on payment.

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available for you on our website to download and print off or available in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

Aims:

The school aims to:

- enable every child to fulfil their learning potential, with education that meets the needs of each child,
- help every child develop the skills, knowledge and personal qualities needed for life and work.

This publication scheme is a means of showing how we are pursuing these aims.

Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in a later section of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

- School Prospectus – information published in the school prospectus.
- Governors' Documents – information published in Governing Body documents
- Curriculum – information about policies that relate to pupils and the school curriculum.
- Key Information -School Policies, procedures, reports and other information related to the school.

Also on the website are:

- Published reports of Ofsted referring expressly to the school
- Section 48 Report: inspection report of religious education in those schools designated as having a religious character (SIAMS report)

Classes of Information Currently Published

Parent information/School Prospectus online – Statutory contents of the school prospectus are as follows; (other items may be included in the prospectus at the school's discretion):

- The name, address and telephone number of the school, and the type of school
- The name of the head teacher and chair of Governors
- Details of the governing body membership
- Information on the school policy on admissions
- A statement of the school's ethos and values
- Details of any affiliations with a particular religion or religious denomination, the religious education provided, parents' right to withdraw their child from religious education and collective worship and the alternative provision for those pupils
- Information about the school's policy on providing for pupils with special educational needs
- Number of pupils on roll
- An overview of teaching, curriculum provision, community links and facilities

Information relating to the governing board

- School Development Plan
- Minutes of meetings
- Membership of the Governing Body and roles.
- Information about how the school works with parents and the wider community

Curriculum

Long term plans/Key Information/Policies and reports

- Special Education Needs and Inclusion Policy (Learning Support policy): information about the school's policy on providing for pupils with special educational needs
- Accessibility Plan: a plan for increasing participation of disabled pupils in the school's curriculum, improving the accessibility of the physical environment and improving delivery of information to disabled pupils.
- Child-protection and Safeguarding Policy: a statement of policy for safeguarding and promoting welfare of pupils at the school.

- Discipline and Behaviour Policy: a statement of general principles on behaviour and discipline and of measures taken by the head teacher to prevent bullying.

- Statement on Primary PE
- SEND report
